Know Your Rights

When in Custody

1. You have the right to remain silent. Never talk to the police unless your lawyer is present. Say, "I want an attorney."
2. If you cannot afford an attorney, ask the police to contact the Office of the Public Defender.
3. Do not think it will be "too late" if you wait for an attorney - you can always give a statement later.

At Home

1. You don't have to let the police enter your home unless they have a warrant. Officers must give you a copy of the warrant and a list of anything they take.
2. Only in emergency situations and if you have consented may the police enter and search your home without a warrant.

Vehicle Stops

1. Upon request, show the police officer your driver's license and registration.
2. If the police ask to search your car, say "no". If they search it anyway, make it clear you did not agree to the search.
3. If an officer gives you a ticket, sign it. It is not an admission of guilt. You can still fight it in court.
4. If you are a driver and an officer orders you out of a vehicle, you must obey the order.
5. A passenger in the car may be ordered out of the vehicle, but does not have to answer questions/ provide information.

Street Encounters

1. If you are stopped, it is not a crime to refuse to answer questions or to refuse to identify yourself.
2. Police cannot lawfully require that you identify yourself or produce identification unless they reasonably suspect you are involved in a crime.
3. You can ask if you are under arrest or free to leave. If you are free to leave, walk away.
4. An officer may do a "pat down" search of clothing if he suspects you have a weapon. Do not resist but make it clear you do not agree to be searched.

WHO WE ARE

WHAT WE DO

We represent **OPD Attorneys are Among the Best Criminal Defense Attorneys in Maryland** defendants charged with committing crimes in **Charles, Calvert, & St. Mary's Counties** and for which the penalty is jail or a fine over \$500.

WHEN AND HOW TO APPLY

If you want to obtain an attorney through The Office of the Public Defender, you must apply in-person for our services at one of our offices at least **ten business days** (do not count holidays or weekends when counting the 10 days) **before** your court date. This application process is called

Intake. You can apply for OPD services in any Maryland county. Do not wait until the last minute to come in for Intake or we might not have enough time to complete the application process.
